OUR MISSION

To enrich the lives and prospects of economically disadvantaged children by providing quality year-round community and camp programs to develop physical, artistic, and social skills, positive attitudes and personal qualities.

OUR HISTORY

Christie Lake Kids has been addressing the needs of economically disadvantaged children from the Ottawa area since 1922, when Judge John (Jack) McKinley founded the summer camp. It is a model for helping kids that has stood the test of time and benefitted greatly from the leadership of the many remarkable leaders including the late Dr. Dan Offord who volunteered as Camp Director for 46 years.

Camp was designed to be not only a summer of fun but also a place for children to learn responsibility and citizenship, develop skills, and find opportunities to succeed. Thousands of children have walked the trails of Christie Lake Kids Camp and had their lives changed by the skills they developed and the support they received. The "Winter Program" began informally in the 1960's, when camp staff organized activities for campers in the off season. In 1985, a full-year commitment to children from low-income families was made by formally establishing the STAR (Skills Through Activity and Recreation) afterschool and weekend programs in the city.

OUR PHILOSOPHY

Christie Lake Kids programs are based on the following principals:

-All kids deserve a safe, healthy childhood -All kids deserve the opportunity to learn, to achieve and to succeed -Teaching skills of all kinds not only builds self-esteem, social skills and other positive qualities -Children from low income families deserve the same recreational and skill development opportunities as other children Caring for children and youth is not just a private issue; it is a collective responsibility.

Camp—a Life time Journey

It was the summer of 1976, my parents had just separated and the **low income neighbourhood** where I had grown up, Penny Drive, had a guy by the name of Bill Burgess who was **visiting** his mother ask me and my friends if we wanted to go to **camp** that summer. Little did I know then how much of an **impact** that day would have on the rest of my life. I attended the next four years as a camper and the following 12 years on staff. Two of my brothers, Serge and Pierre, followed suit.

The summer I turned 15 I got a call from Tom Pritchard because they were short a camper for the first session and wanted to know if I would go up as a camper. Needless to say, I accepted and that session our cabin won best cabin two days into the break between sessions, camp needed a Junior Staff position and guess who got a call from Junior Staff Director, Joey Johnson? That's right, me!

Growing up poor or on "welfare" had a lot of **stigma** attached. In school, I tended to not feel as smart or as **worthy** as those middle class kids or as we referred to them as the "rich" kids... I did not believe I deserved anything better that what I was getting. This belief persisted until I began gaining some **self worth and esteem** outside my community at a place called Christie Lake.

After years of seeking my path as an adult, I found my way to CLK again through a camp for young offenders. I began to realize that I could have a career doing exactly the same work I longed for every summer that I had worked at CLBC: I help others through their own path of feeling worthy.

I am in the process of revising my thesis and will be receiving my

Masters of Counseling Psychology degree June 2011. I have three
beautiful children and have been married for 17 years. I continue to

utilize all of what I had learned at CLBC throughout my career as a
youth care worker and social worker. In 2004, I began a program
based on Camp and STAR principles which continues to serve at risk
children today (Northern Star Kids)

Thank you Christie Lake Kids and I promise to continue working at making the world a fairer place for all children!

The Year Round Effect

I was sitting at my desk at school the first time I heard about Christie Lake. An announcement came over the PA "anyone who wants to go to Christie Lake Camp can come down to the office and pick up an application". I really wanted to go, camp sounded like a lot of fun... but living in a single parent family made cost a real issue, I just hoped it was possible. For sure, the first thing my mom asked when I showed her the form was how much it cost, I am so happy that she called the office. The people at CLK explained to her that it was free, I was off to camp!

After my first time at camp I would count the days till next registration, I looked forward to it all year... between camp and STAR I had so many good things happening. Camp offered me new experiences out of my neighborhood and away from the realities of home. We moved a lot, and STAR provided me with stability when there were a lot of changes in my life.

I have lived with the realities of growing up in poverty, in unsafe communities and with out many options; I have also grown up with a parent who has Bi-Polar disease. My mom's mental illness has presented me with a lot of barriers in connecting with my community, and making friends, my sense of self and my relationship with her and my siblings. The Staff of CLK encouraged me to learn more about my mom's illness and to talk to her about it, which made a huge difference for me... they supported me through a difficult time in developing my understanding. Christie Lake Kids programs taught me how to be a better friend, manage my emotions, and find pleasure in giving support to others. My favourite saying is "A life lived for others is a life worthwhile" and that is how I go day by day.

Now I am 17, in my second year of the LIT Program, and I still count down the days to camp! I volunteer at swimming, dodge ball, hockey and volleyball and this summer I plan on working at Camp as a Counselor. I love that I can give a little of my time and make a little kid's whole week.

CLK really started me in learning about being a good mentor, and thinking about the future. I want to be a Lawyer, I think I want to be a children's advocate through human right's law.

Words alone can not explain the difference CLK has meant to me, to my life, and to my family in helping us **bridge the gaps that poverty creates**. **Every child deserves the chances and the opportunities** that we have all been given at Christie Lake Kids.



For the rest of my days I will give back to Christie Lake Kids.







TREASURER'S REPORT

2010 can be best described as a "turn-around" year for Christie Lake Kids. In contrast to 2009 where the economic downturn took a toll on Revenues and CLK posted a ~\$93,000 deficit, 2010 saw Revenues strengthen, and as a result the year ended with a \$97,000 surplus. As demonstrated in the financials, this \$190,000 swing is the result of a ~\$175,000 increase in year over year revenues and a ~\$15,000 decrease in year over year expenditures. To further put the significance of this in context, at the beginning of 2010 the Board of Directors approved a Budget that projected a deficit of approximately \$50,000, so ending the year with a ~\$97,000 surplus represents a ~\$150,000 improvement!

2010 was also significant in that Christie Lake Kids conducted an extremely successful capital campaign called "Rock the Dock" which raised \$53,000 to rebuild the antiquated docks at camp, and began laying the foundation to long-term sustainable funding with its first endowment fund of \$10,000 in the name of the Ward family. It should be noted that although from an accounting standpoint this \$63,000 in capital donations gets treated as Revenue and contributes to the \$97,000 surplus, from a pure operating standpoint, Christie Lake Kids ended the year with an "operating" surplus of \$34,000.

In keeping with building sustainable longterm funding, the Board of Directors approved investing in a software package called Raiser's Edge which will improve how Christie Lake Kids interacts with its donor base and should allow CLK to capture opportunities that were previously missed. In addition, the market value of the Christie Lake Kids investment portfolio reached an all-time high in 2010, ending the year at ~\$342,000. After adjusting for net in-flows of ~\$25,000 over the year, this represents an increase of ~\$14,000 or 4.6% for 2010. Equity investments continue to be focused on conservatively managed funds holding dividend paying stocks and, where appropriate, shares which have been donated to Christie Lake Kids.

Given the current level of interest rates and the conservative nature of our investment policy, we have established a total return target of 4% for 2011.


